Nebraska Total Care announced that Adam Proctor has been appointed as Plan President and Chief

MEMBER IMPACT

Pregnancy and newborn care, anytime and anywhere

Nebraska Total Care has partnered with Pomelo Care to provide virtual pregnancy and newborn support for our members. Pomelo Care is designed to supplement the care provided by the medical practitioner, and provide additional support between in-person appointments. They work in collaboration with the our Care Management team to create individualized and inclusive care plans.

Through a mobile app, members have access to 24/7 personalized care via text, phone, and video from professionals such as nurses, midwives, mental health providers, dietitians, doulas, and lactation consultants. Members also have the option to participate in support groups with peers at similar stages of pregnancy and early parenting.

In the first two months of service, we have seen strong engagement with members. **Members are engaged on an average of 3-4 days per month, with satisfaction reports of 5/5.**

- A member was diagnosed with pre-eclampsia.
 The Pomelo Care nurse meet with her daily to monitor her blood pressure.
- A member reported to Pomelo Care that she was being evicted from her home the next day.

 Nebraska Total Care connected with the member immediately to find both short- and long-term housing solutions.
- A member identified that she was experiencing domestic violence. Our Care Management team helped her move to a safe location and continues to help her plan for her safety and the needs of her baby.
- A member had questions about aftercare following a Caesarean. She send photos of her incision to a Pomelo Care nurse and received immediate answers to her questions.

DENTAL COVERAGE IMPLEMENTATION

Effective on January 1, 2024, Nebraska Medicaid and Long Term Care will integrate dental management into the coverage provided by the Managed Care Organizations. Integration allows members to use one Managed Care Organization for all services, including dental, medical, behavioral, vision, and pharmacy care. Additionally, it empowers Nebraska Total Care to provide comprehensive and holistic care to members.

Nebraska Total Care has worked diligently to ensure that members and providers will experience a smooth transition on January 1.

DENTAL EXPERTISE

Dr. Holly Randone, DDS, MS has joined Nebraska Total Care as the Dental Director. Dr. Randone has a passion for working with children and medically compromised patients. The Beatrice, Nebraska, native earned her Bachelor of Science from Hastings College and her Master of Science from Ohio State University. She earned a Doctorate of Dental Surgery from the University of Nebraska Medical Center – College of Dentistry, where she graduated with distinction, and also holds a certificate in Pediatric Dentistry.

Dr. Randone has been in private practice in central Nebraska since 2010, and received her board certification by the American Board of Pediatric Dentistry in 2011. She also serves as an adjunct Faculty member of Pediatric Dentistry at the University of Nebraska - College of Dentistry.

Implementation activities ensured that members could receive services on January 1, 2024 without interruption.

- Nebraska Total Care built a comprehensive dental network to provide access to care for our members. Electronic processes and Provider Services are in place to support providers through service delivery.
- In collaboration with the other Medicaid Managed Care Organizations, we have coordinated the dental services requiring prior authorization. Dental providers will have similar requirements for all Medicaid members regardless of their plan.
- Provider webinars have been offered throughout December and January to ensure providers have the training to provide services.
- All members received new ID Cards prior to January 1, which included the name and phone number of their Primary Dentist.
- Member outreach includes educational information on preventive care and treatment for oral health.
- · Our website includes dental resources for members and providers.
